Mātaimoana

Our commercial arm, Taranaki Whānui Limited, with support from Trustees and development partner The Wellington Company, have developed and submitted an application to the Minister for the Environment seeking a referral for our proposed development of Mātaimoana through the Fasttrack Consenting Process.

The site, as you may be aware, along with the entire Crown landholding on the Miramar Peninsula (Motu Kairangi) formed a key part of our Settlement with the Crown.

We have waited in anticipation for the opportunity of the whenua to be returned via the first right of refusal option, noting of course that this opportunity does comes with significant purchase cost of \$23.3m.

We have worked hard, and in partnership with Crown, including the Ministry of Housing Urban Development (MHUD) and other Crown agencies (including LINZ) to identify a pathway forward that will meet our cultural, social, commercial, and environmental objectives.

The development of Mātaimoana proposes to deliver between 650 – 700 new homes in what will be, our newest kāinga, which its design and development will be underpinned by our Taranaki Whānui principles:

- Our whenua connect, revitalise, grow, teach, learn, sustain, utilise and acknowledge.
- Our moana vitality, nurture, spiritual, peace, pure, respect.
- Our awa tranquil, serene, joy, signs, sacred, power.
- Our uri empower, unity, lwi, Hapū, Whanau, marae, aroha.

It is proposed that Mātaimoana will be underpinned by a perpetual leasehold model – which enables us to retain the whenua and applying the key design outcomes which are summarised below:

- To create a legacy to be admired, celebrated, and cultivated further for the prosperity of our future generations
- Setting goals and expectations which will ensure that we are driving towards new heights of growth and development in a way that intimately builds on our identity as Taranaki Whānui
- To ensure that Mātaimoana embraces the presence of Taranaki Whānui to maintain prominence, guardianship, culture, and identity of the surrounding whenua, awa and moana.

Most importantly we want to provide a housing future for our uri, the community and a tupuna legacy for our mokopuna who are yet to come and want to live within our takiwā.

We are ensuring that our aspiration for Mātaimoana is based on papakāinga principles, which can be seen in the <u>attached</u> draft piece of work completed by Len Hetet which helped inform us when crafting the application. This document will help guide us in this mahi and we will, if the application is referred, seek further participation, direction, guidance and support from uri as to the design, and other elements of our kāinga project.

It is proposed that Mātaimoana will be delivered by Taranaki Whānui in partnership with The Wellington Company and MHUD and a Tai Hekenga consortium pursuant to the land for housing programme. This is a key partnering opportunity for Crown and Mana Whenua as we collectively respond to the housing crisis and challenges we have for our own uri and others who reside in our takiwā.

We are excited for our people and the opportunity this will present if the application is approved. We, like you, wish to be able to get on with the mahi needed to create what will be for us, a very special part of our takiwā, and a catalyst for wider opportunities across Motu Kairangi and Miramar Peninsula.

Kia ora koutou

Thank you to everyone who responded to the survey for the Regulatory Process Committee papers that we considered last. Obviously there are a number of improvements that we need to make to our survey methodology and we will work on those prior to the next committee pack coming out around 26 Jan for the Environment and Infrastructure (EIC) Committee Scheduled for 2 Feb.

We had 16 people respond to the survey, and those who responded voted 142 times on the individual resolutions and provided 15 unique comments. Broadly the votes and comments indicated good support for all of the papers with the exception of the proposal to stop part of the Orangi Kaupapa Rd Reserve so it could be sold to an adjoining home owner. On that paper the comments centred around the theme that the land proposed to be disposed should be returned to iwi. For that reason I moved an amendment (which was unanimously supported by the Committee) that the land be first offered back to iwi. In addition the Council Chief Planner advised me that he will be reviewing their processes so that ALL proposals for disposal of Council owned land first go through an offer back process with iwi.

Ka pai whānau, thanks again to those who participated. Your input was really helpful and it gave me confidence about how I should be advocating for your interests. Keep an eye out for the EIC papers that I will publish on this platform around 26 Jan ahead of the 2 Feb meeting. Have a safe and relaxing summer holiday everyone!!
